However, we strive to maintain consistency and strength among chaos. We've built our **REPUTATION** on the **RELIABILITY** of our staff and the **RESULTS** our patients achieve. Perhaps the best evidence of that is our recognition as a Top Agency of the 2012 HomeCare Elite. If you dig a little deeper, this achievement is backed by Medicare's own Home Health Compare. What an accomplishment!

As we look to 2013, the challenges don't go away. Home care providers face a two percent rate cut early in the year as Medicare implements over \$700 billion in cuts. There are several other options being considered as well, including additional rate cuts and structural changes which may raise the eligibility age and/or require a co-payment for home health care services. Of course, we will keep a close eye on these proposed changes.

In the meantime, we will continue to focus on continually improving the care we provide to our patients and building on our strong reputation. Throughout this Annual Report, you will read about that reputation and results our patients reliably achieve. We are proud to serve our community and our patients. We are proud to serve you and we truly appreciate your support.

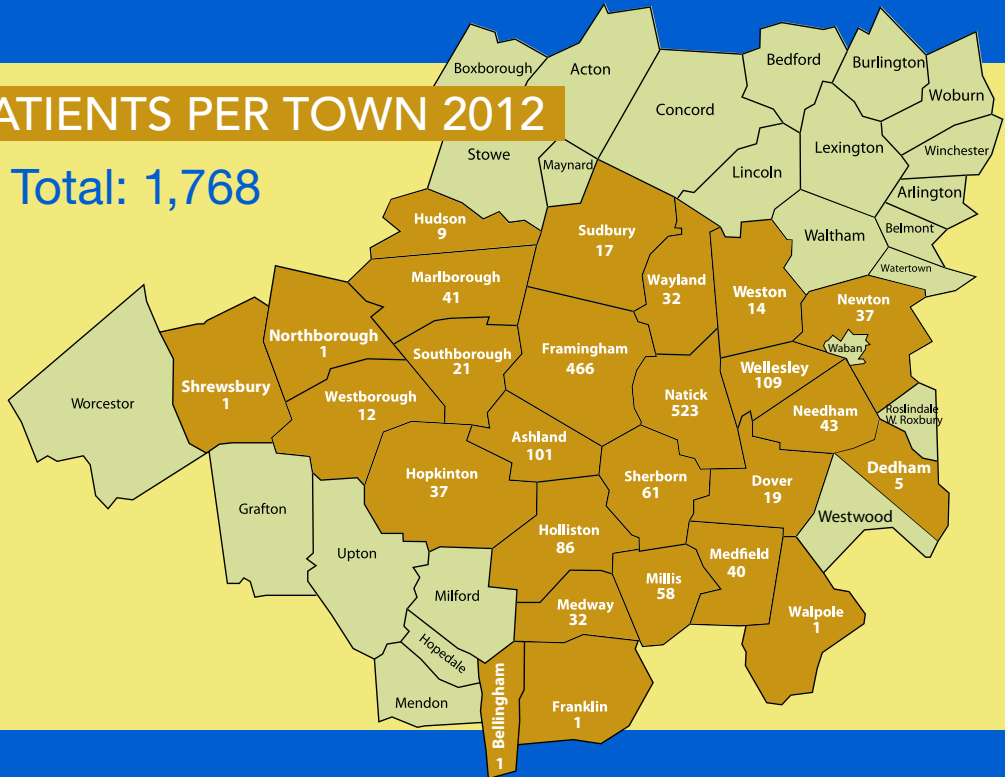

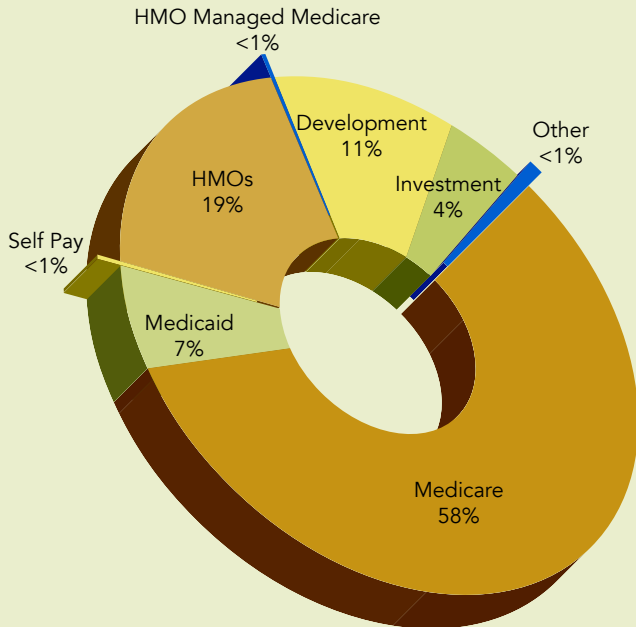

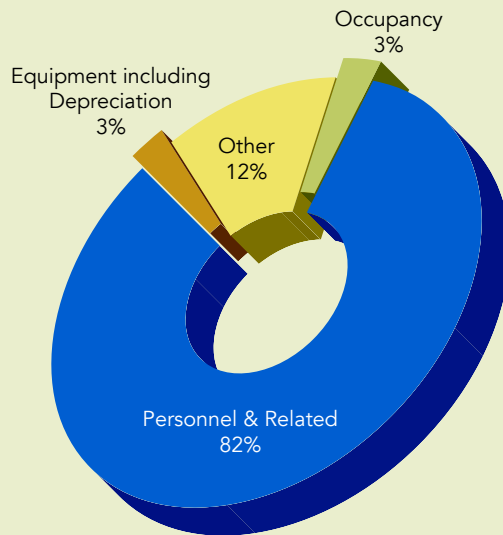
